

2.1.1. Curricular Design and Development:	 The curriculum is designed by affiliating University with participation of College faculty on undergraduate BoS. The University-College faculty interactive sessions are put in place for effective curriculum delivery and transaction of courses. Study tours are organized to industry and relevant institutions for operationalization of curriculum. 	
2.1.2 Academic Flexibility:	 The College offers undergraduate courses having limited academic flexibility in terms of programme options. The institution follows semester system.

2.1.3 Curriculum enrichment	 courses is ensured by industrial and field visits. Environmental studies and general knowledge focus comprising value addition in courses is yet to be offered. Value added courses are yet to be offered in
	programme options.
2.1.4 Feedback System:	 The oral feedback is collected from stakeholders and analyzed by IQAC. The feedback based of structured format is yet to be put in place by IQAC.

2.2 Teaching-Learning & Evaluation:	
2.2.1 Student Enrolment and Profile:	 The admission process is guided by affiliating University and publicized through prospectus, notices and is put on College website. Admissions are made on the basis of merit and is governed by state reservation policy. About 90 percent students on rolls are from under-privileged and tribal sections society.
2.2.2 Catering to Student Diversity:	 Mechanism is in place to identify slow learners and assist them through remedial classes. The College provides academic counseling to slow-learners.
2.2.3 Teaching-Learning Process:	 The College conducts preliminary sessions on academic calendar issued by the affiliating University E-learning methods are yet to be put in place to enrich teaching pedagogy. A system of mentor-mentee to meet academic needs of students and creative and innovative learning process is partially visible.
2.2.4 Teacher Quality :	• While 6 out of 30 faculty members are Ph.D and 8 teachers are M.Phil degree

	 norms. Most of the faculty has undergone refresher/orientation courses.
2.2.5 Evaluation Process & Reforms:	 The scheme of evaluation process is notified to students. The affiliating University has introduced grading system and semester scheme that is followed by the College. The College has internal test mechanism for internal assessment of students.
2.2.6 Student Performance and Learning outcomes:	 The student enrolment is declining and the pass percentage at final stage is above 70. A few students have got University Gold Medals.
2.3 Research, Consultancy & Extension:	
2.3.1 Promotion of Research:	 The College has initiated some measures to promote and facilitate research. The College invites eminent academics for lectures and interaction to motivate faculty to pursue research. Four teachers are research guides and three teachers have undertaken minor research projects from UGC.
2.3.2 Resource Mobilization for Research:	 The budgetary support and grant mobilization for research is yet to be initiated. The institution has mobilized about Rs 1.55 lakh from UGC by way of taking up minor research projects.
2.3.3 Research Facilities:	 Limited research infrastructure including scientific equipments is in place. The College is yet to have collaboration with academic institutions to avail of research facilities.
2.3.4 Research Publication and Awards:	 Some faculty members have a few publications in peer reviewed journals to their credit.

2.4.1 Physical Facilities:	The administrative and academic block, the play-ground, labs including computer lab, audio and video gadgets are in place.

	The women's hostel is under- construction and canteen facility is yet to be made available.
2.4.2 Library as a Learning Resource:	 Library remains open between 10 am to 4 pm and has built up area of 135.30 sq mts with 50 seating capacity. The library is yet to be automated and has internet facility.
	The average walk-ins are 50 per day, books issued/returned 28 per day with

		reprographic facility in place.
2.4.3	I T Infrastructure:	 The College has 33 computers, 5 laptops, one LCD Projector and 12 computers have LAN based internet facility. The annual budgetary provision for upgradation of IT facility is yet to be put in place. ICT- enabled learning process is yet to be put in place, however, the institution avails MKCL knowledge network connectivity with affiliating University.
2.4.4	Maintenance of Campus Facilities:	 The institution has limited staff and no provision for maintenance of campus premises. The up-keep of labs and IT infrastructure is yet to be augmented.
